## Background

The United Nations Department of Economic and Social Affairs (UN DESA), through its Division for Public Institutions and Digital Government (DPIDG) and its Project Office on Governance (UNPOG), in collaboration with the Korea Research Institute for Local Administration (KRILA) co-organized the Innovative Local Governance Webinar to launch the Handbook Series on [Innovative Local Governance for the Implementation of the Sustainable Development Goals](#) held on 20 August 2024.

The United Nations General Assembly Resolution [A/RES/69/327](#) emphasizes the growing need to strengthen public institutions and public services in support of sustainable development. The [2030 Agenda](#) for Sustainable Development, adopted in 2015 by all member states aims to achieve the 17 Sustainable Development Goals (SDGs) as a holistic and interdependent agenda of all countries. UNPOG an integral part of DPIDG/UN DESA, in collaboration with KRILA, developed the Handbook Series on [Innovative Local Governance for the Implementation of the Sustainable Development Goals](#).

Through a series of compact and succinct publications that are convenient for prompt digest, the Handbook Series contributes to promoting effective, accountable, and inclusive public institutions in advancing the implementation of the 2030 Agenda for Sustainable Development at sub-national and local levels. The Handbook Series also complements the Training Toolkits which are part of [the Curriculum on Governance for the SDGs](#) developed by UN DESA. The materials are useful for capacity development workshops and training organized by UN DESA and other UN agencies. It can also be used by schools of public administration, institutes of public management and local authorities.

## Objective

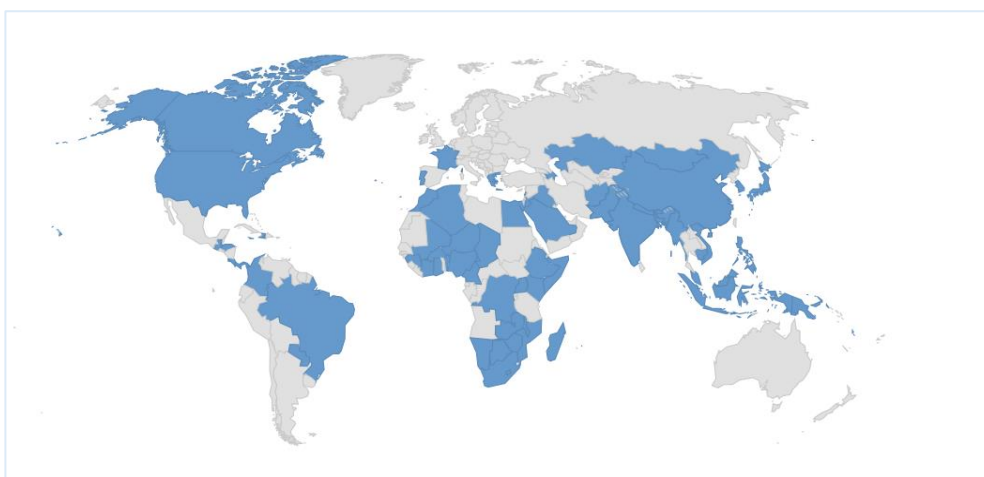
The Webinar was aimed at officially Launching the Handbook Series on Innovative Local Governance for the Implementation of the Sustainable Development Goals.

## Participants

The Webinar welcomed participants from diverse background including policy makers, public sector, private sector, practitioners, researchers, NGOs, and other stakeholders from national and local governments, civil society organizations and institutions engaged in promoting innovative local governance.

The Innovative Local Governance Webinar was attended by **272 participants** from **69 countries**, mainly from Asia - Pacific, and Africa. 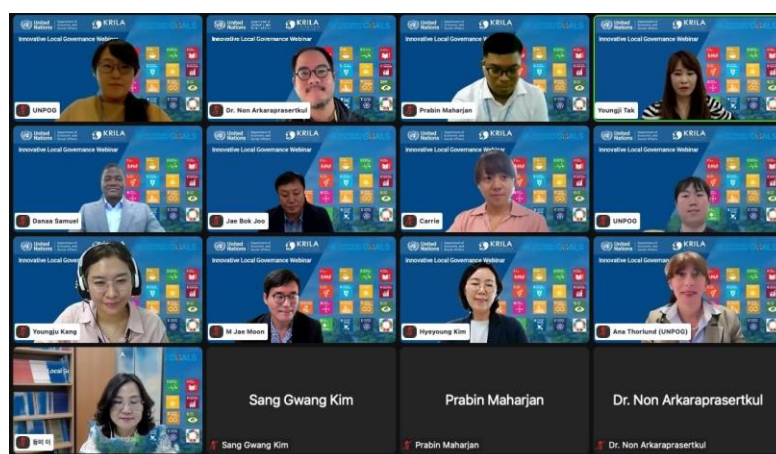
## Participant's Feedback

A total of **102 participants** from **25 countries** responded to the **post-event survey**. The post-event evaluation was undertaken to solicit participants' feedback to ensure measurable and sustainable impact of the webinar on the participants' country, institution, and on their personal learning objectives. Summaries of the results are highlighted below:

- Overall, **100% (all 102 respondents)** expressed their satisfaction with the webinar.
- Approximately **97% (99 respondents)** indicated the Handbook Series will benefit their current job or studies.
- About **88% (90 respondents)** stated they plan to use or access the Handbook Series as soon as possible while **12% (12 respondents)** plan to use or access the Handbook Series in the near future.

## Key Insights and Messages

**Ms. Hyeyoung Kim**, Head of UN Project Office on Governance, DPIDG/UN DESA, Incheon, Republic of Korea, in her remarks stated that effective, accountable, and inclusive public institutions play a significant role in achieving the 2030 Agenda. She reiterated that the Handbook Series is not just a collection of publications; but a dynamic and practical resource aimed at empowering local governments to take decisive action. The objectives of this Series are multifaceted but unified, aimed at empowering local governments to be catalysts of sustainable development. It seeks to enhance their capacity to build resilient and inclusive societies, to mainstream the SDGs into local policies, and to foster effective, accountable, and inclusive governance.

The Handbook Series has the following objectives:

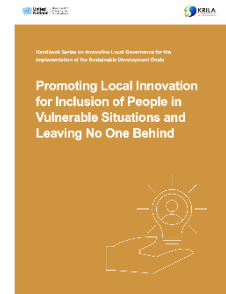
- To introduce diverse strategies, approaches, and policy tools to enhance one country's capacity and readiness for building sustainable and resilient societies at all levels;

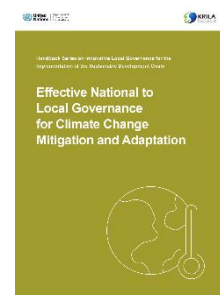

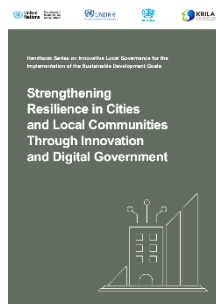

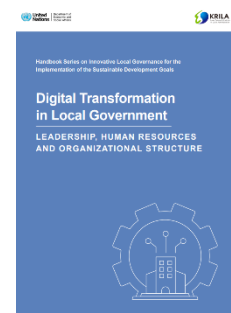

#### 4. [Digital Transformation in Local Government Leadership, Human Resources and Organizational Structure](#)

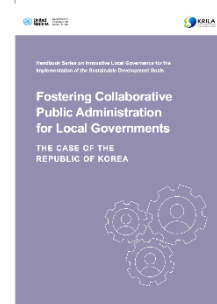

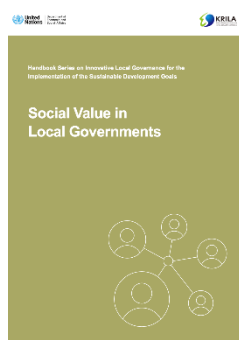


## 5. Fostering Collaborative Public Administration for Local Governments - The Case of Republic of Korea

## 6. Social Value in Local Governments



- This handbook furthers the discussion on the premise that social value is the main axis of the paradigm shift of local governments oriented towards traditional development administration. The handbook focuses on what should be done by local governments to spread social value, directly accommodating the demands of residents. The handbook presents the actions local governments must take to promote social values as five means, based on a new government framework. The handbook also presents relevant cases for each means. Action steps and exercises needed and factors to be considered in implementing social value are also included.

## Promoting Innovative Local Governance for the Implementation of the SDGs<sup>1</sup>

### Where are We Now on the SDGs?

- The world is woefully off track to achieve the SDGs by the 2030 and policy makers must therefore examine how countries can get back on track and make the transformative development agenda a reality.

### SDG Localization, Local Governance and Urbanization<sup>2</sup>

- Countries have recognized that many of the roadblocks to achieving the SDGs, such as non-income poverty and inequality, must be addressed through SDG localization and by improving local and urban governance. This requires a whole of society approach and a transformation process i.e., through innovation in the way that public institutions, private sector and citizens collaborate to achieve sustainable development.
- Localizing the SDGs cannot be limited to integrating the global goals in local development plans but must extend to strengthening local governance. This includes by using innovation (social and technology) to codesign with public and private actors new service delivery models, innovative financing tools and accountability mechanisms.

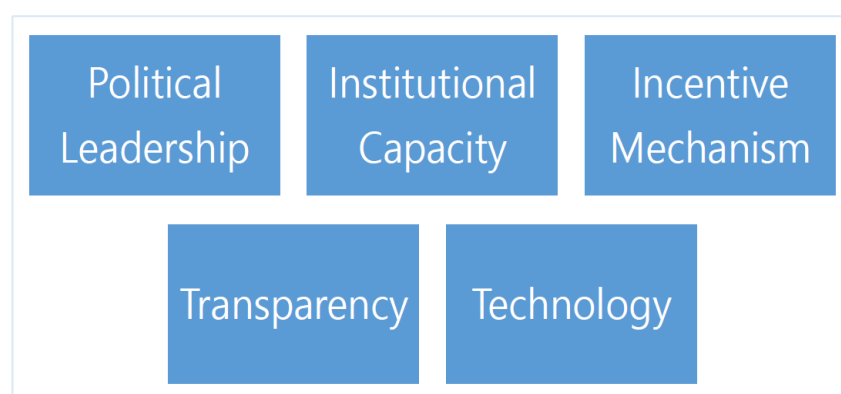

## Innovations in Local Governance for building resilient communities and accelerating progress on the SDGs: Thailand's Experience<sup>3</sup>

### Challenges of Traditional Civic Issue Reporting

- Cities face challenges in identifying and addressing infrastructure problems due to **limited resources**, while citizens encounter difficulties in reporting civic issues to local governments, often exacerbated by a **communication gap**. The **overreliance on paper-based systems** slows down processes and creates obstacles in effectively resolving issues, which further hinder the efficiency of local governance.

## Solving Civic Issues with A Citizen-Centric App

- **My City App** is a Citizen-Centric App for addressing civic issues as it provides a seamless communication channel between citizens and the government, facilitating efficient problem-solving. My City App enables citizens to report issues directly to their city via the popular line messaging app.
- Putting it all together, it is important to have purposeful technology, consider value over optimization, and think big, act small, and consistently.

Building Resilient Communities through Innovations in Local Governance requires:

- **STRIPE Framework:** this outlines the five key challenges faced by local municipalities in implementing the SDGs: stakeholders' understanding, trust, regulations, inclusivity, procurement, and economic management models. Addressing these challenges is essential for any successful SDG implementation.
- **Gradual Buy-ins:** when introducing new services and solutions. By gradually building awareness and skills, digital efforts can be more effectively implemented, ensuring that communities are ready to embrace change.
- **3Rs Model:** this involves Reduce, Replace, and Reform. This strategic approach is crucial for implementing innovative solutions, particularly in sectors like energy. We cannot overhaul infrastructure overnight, but through gradual reduction, replacement, and reform, we can achieve meaningful and sustainable change.

## Policy Recommendations for Innovation in Local Governance

- **Strengthen Local Capacity for SDG Implementation** - Local governments should focus on building capacities to integrate the SDGs into local policies. This includes introducing innovative governance models, fostering collaboration with the private sector, and ensuring inclusive governance that leaves no one behind. Leveraging the handbook series and toolkits from the UN and other organizations can guide local authorities in implementing these frameworks.
- **Emphasize Social Inclusion** - Local governance innovations should prioritize leaving no one behind by ensuring social inclusion of vulnerable populations. Policies should embed social

value into legal and public service frameworks, focusing on equity, sustainability, and community well-being.

- **Address Climate Change Resilience** - Promote innovative governance strategies for climate change mitigation and adaptation. Local governments should invest in digital and risk-informed governance approaches to enhance resilience in communities, building on global best practices and toolkits provided by initiatives like the UN's Handbook Series.
- **Foster Collaborative Governance** - Collaborative public administration should be expanded to include private sector actors. Local governments must actively share information, financial resources, and human capital across sectors. Legal frameworks and support systems should be enhanced to facilitate collaboration, with dedicated organizations or teams responsible for promoting and executing joint initiatives.
- **Enhance Digital Transformation** - Local governments should prioritize digital transformation to improve efficiency, transparency, and service delivery. This includes developing a future-ready workforce through digital literacy training and aligning human resource strategies to meet digital demands. Additionally, optimizing organizational structures and processes with digital tools will streamline governance.
- **Promote Social Value in Governance** - Governments should embed social value into public service delivery and legal frameworks. Policies must prioritize sustainability, equity, and community well-being, using clear metrics to measure outcomes. This will require a proactive approach to promoting social innovation and ensuring accountability in governance.
- **Localize SDGs Through Innovation** - Local governments should integrate the SDGs into their policies by adopting innovative service delivery models, new financing tools, and accountability mechanisms. This requires a “whole of society” approach, involving public-private partnerships and community engagement.
- **Leverage Innovation for Climate Action** - Equip local governments with innovative tools for climate change mitigation and adaptation. This includes providing roadmaps, policy toolkits, and peer support to implement resilient strategies that address local climate challenges.

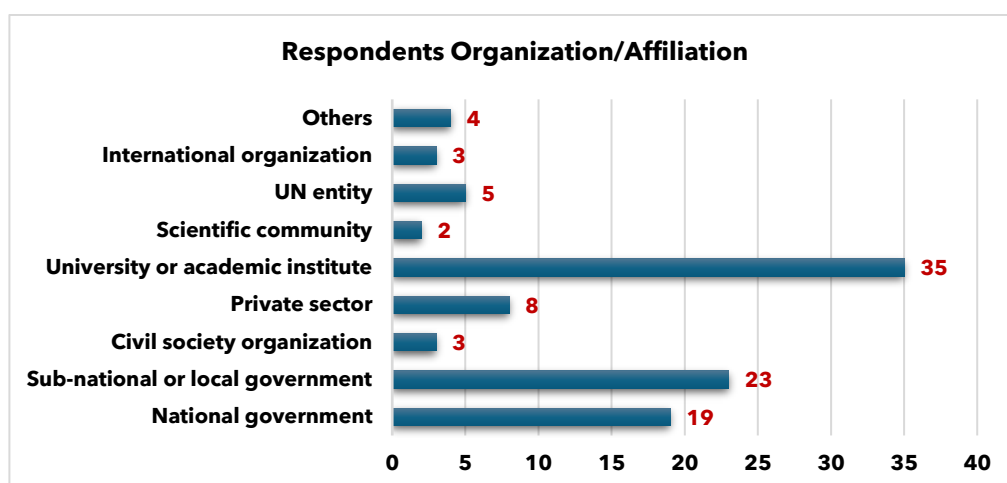
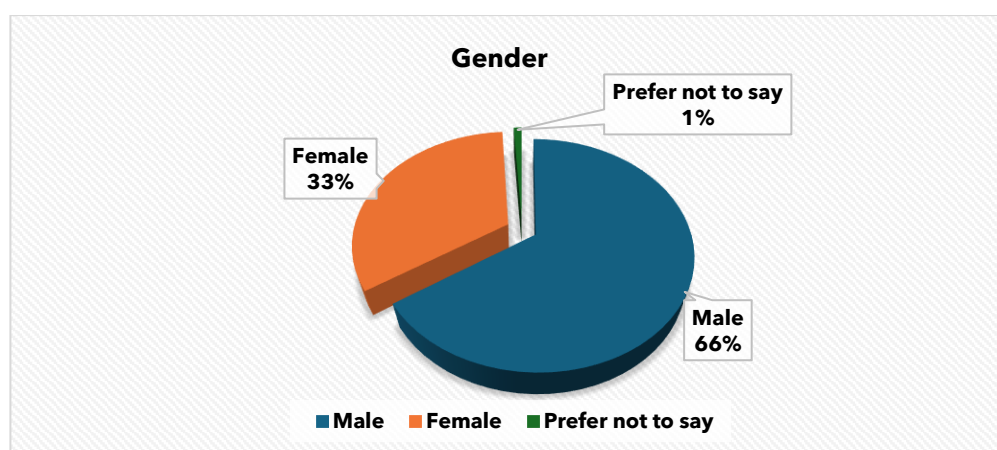

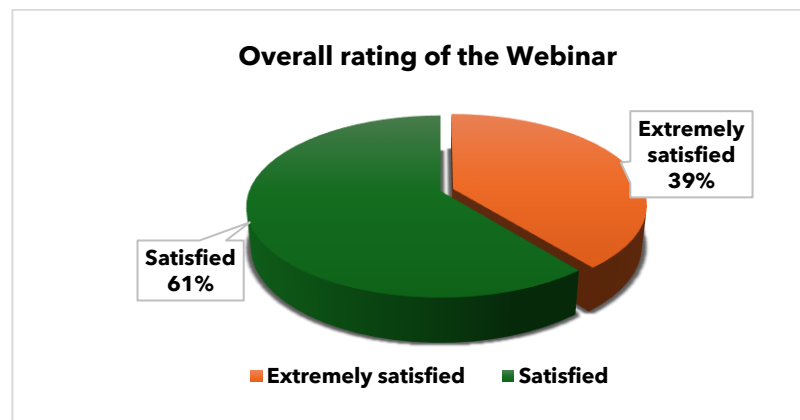
#### Background

The respondents were composed of 67 (66%) males, 34 (33%) females, and 1 (1%) preferred not to say. Most of the respondents 35 (34.3%) were from university/academic institutions, followed by 23 (22.5%) from sub-national/local government, 19 (18.6%) from national government, 8 (7.8%) from the private sector, 5 (4.9%) from UN entities, 3 (2.9%) from civil society organizations, 3 (2.9%) international organizations, 2 (2%) from the scientific community and the remaining 4 (3.9%) from other affiliations.

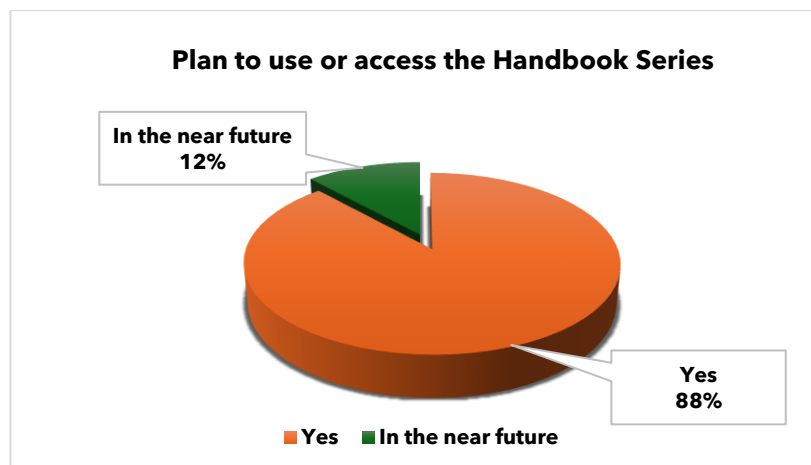


### Overall rating of the Innovative Local Governance Webinar

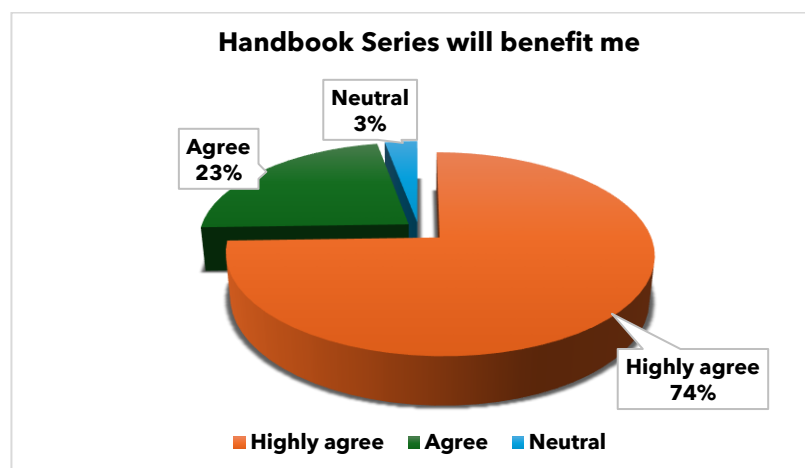
Overall, 62 respondents (61%) indicated they were extremely satisfied with the webinar with 40 (39%) stating they were satisfied with the webinar.
