Current Problem & Aim

Current Problem:

- **Youth's lack of power:** How COVID-19 has disproportionately affected the youth.
 - Educational opportunities are compromised.
 - Job opportunities are shrinking.
- **Ineffective governance:** How policies lack efficacy due to policymakers that cannot have the same first-hand insight into the problems the youth experience.
 - Unjust Educational policies.
 - Ineffective distancing/protective measures at school.
 - Lack of youth unemployment measures.
 - Overload of work for the admin.

Aim:

- To capture the youth's voice to correctly **identify**, **analyze**, and **solve** youth-specific problems generated by COVID-19.



Advisory

Short-term:

- SDG 17: Hiring youth COVID **policy advisors** for the **legislative branch** to capture the youth's voice.
 - In particular, youth's environmentally conscious nature will allow for **GREEN** recovery through virtual events.
 - SDG 17: Setting up **student-ambassador programs** to facilitate interaction.
 - Middle/high school, university-level, and job-entrance policies will be advised.

Long-term:

- SDG 9: Using **cutting-edge technologies** for resilience-building.
 - How the **metaverse** will create better education and job-training.
 - How **remote medical tools** will prevent the spread of COVID-19.
- SDG 12: Develop ways that consumption and production, particularly in the context of COVID-19, can become more **Green/Sustainable** in the long-run.
 - Reducing plastic usage



Implementation

National Government:

- SDG 17: Constituting a Youth Policy Task Force that consists of youths and professionals where the youths can advise the drafting and implementation of COVID policies on **education and jobs**.
 - How **welfare** administrations, **medical** needs, and **law** enforcements should be reinforced for the youth.
 - The youth can also reach out for potential **partnership** with innovative private sector companies, including start-ups, so that the government can have access to the most advanced technologies in the fields.

Local Government:

- SDG 8: Providing job offerings to combat unemployment.
 - How job opportunities will reduce admin's **workload** and provide industrial **growth**.
 - The youth are going to be particularly useful for regulation enforcement and facilitating youth-related policies including in the areas of education and job training.



Measurement: Qualitative and Quantitative

Qualitative

Conduct **surveys** using the internet and posters, to observe **realistic effects** of the proposal for youths

Quantitative (KPIs)

- # of youths engaging in **policy-making**
- # and % of **youth-related COVID-19 policies** that includes youth participation
- # of **new jobs** available to the youth
